

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Supporting the Application of Willard R. Manuel for Nomination to the Arizona
State Boxing Commission)**

RESOLUTION NO. 03-568

1 **WHEREAS, the Desert Diamond Casino, an enterprise of the Tohono O'odham Nation, has**
2 **sponsored and intends to continue sponsoring professional boxing matches; and**

3 **WHEREAS, the sport of professional boxing is one which is traditionally subject to regulatory**
4 **control; and**

5 **WHEREAS, the Tohono O'odham Nation is currently negotiating an intergovernmental**
6 **agreement with the State of Arizona that would allow the Arizona State Boxing**
7 **Commission to regulate professional boxing on the Tohono O'odham Nation; and**

8 **WHEREAS, there will be one vacant seat on the Arizona State Boxing Commission in January of**
9 **2004; and**

10 **WHEREAS, Willard R. Manuel has submitted his intent to apply for nomination to the Arizona**
11 **State Boxing Commission.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **support the application of Willard R. Manuel for nomination to the Arizona State**
14 **Boxing Commission.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
16 **of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (l) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
19 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
20 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
21 **Stat. 984).**


