identified under 638 Contract under line item 750 Major Capital Equipment)**

RESOLUTION NO. 03-569

1 **WHEREAS, the Tohono O'odham Nation Police Department was awarded a Community Oriented**
2 **Policing Services - Tribal Resources Grant Program Equipment Award, funding**
3 **through the U.S. Department of Justice in the amount of \$537,300 under Grant**
4 **Number 2003HEWX0114; and**

5 **WHEREAS, the grant is to be used specifically for equipment; and**

6 **WHEREAS, a partial waiver has been granted for the local required match of 25% with 10%**
7 **determined as appropriate for the Nation's contribution of the total project costs**
8 **during the course of this grant; and**

9 **WHEREAS, the matching contribution has been identified under the BIA 638 Contract under line**
10 **item 750 Major Capital Equipment of \$59,700 for a combined total project cost of**
11 **\$597,000; and**


12 **WHEREAS, the Tohono O'odham Nation Police Department requests the Tohono O'odham**
13 **Legislative Council to approve the acceptance of this grant and budget in the amount**
14 **of \$537,300; and**

15 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**
16 **hereby accepts and authorizes the implementation and expenditure of this grant**
17 **award and COPS Budget in the amount of \$537,300, and waives the indirect cost as a**
18 **requirement of this particular grant; and**

19 **BE IT FINALLY RESOLVED, by the Tohono O'odham Nation Legislative Council that it also hereby**
20 **accepts and authorizes the matching contribution of \$59,700 identified under the BIA**
21 **638 Contract under line item 750 Major Capital Equipment.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH Day**
23 **of DECEMBER, 2003 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
