5	WHEREAS,	under the Emergency Dispatch Services Agreement the Drexel Heights Fire District
6		provides emergency dispatch services to the Tohono O'odham Fire Department at an
7		agreed price per dispatched call; and
8	WHEREAS,	the parties have agreed to continue the mutually beneficial arrangement for an
9		additional year at the price of \$20.00 per dispatched call, increased from \$16.00 per
10		${\bf dispatched call, and to execute a new Emergency Dispatch Services Agreement for the}$
11		time period October 1, 2003 to September 30, 2004 which is identical to the previous
12		agreement except for the price increase; and
13	WHEREAS,	the Domestic Affairs Committee and the Budget and Finance Committee have
14		reviewed the proposed agreement and recommend approval by the Legislative
15		Council.
16	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
17		the Emergency Dispatch Services Agreement with Drexel Heights Fire District
18		substantially in the form attached hereto, and authorizes the Chairwoman of the
19		Tohono O'odham Nation to execute it and any further amendments extending the
20		term of the agreement.
