

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Emergency Dispatch Services Agreement Between the Nation and Drexel Heights Fire District for FY 2004)**

**RESOLUTION NO. 04-005**

1 **WHEREAS, the Tohono O'odham Nation entered into an intergovernmental agreement called an**  
2 **Emergency Dispatch Services Agreement with the Drexel Heights Fire District on or**  
3 **about August 16, 2002, which was extended by Amendment No. 1 until September 30,**  
4 **2003; and**

5 **WHEREAS, under the Emergency Dispatch Services Agreement the Drexel Heights Fire District**  
6 **provides emergency dispatch services to the Tohono O'odham Fire Department at an**  
7 **agreed price per dispatched call; and**

8 **WHEREAS, the parties have agreed to continue the mutually beneficial arrangement for an**  
9 **additional year at the price of \$20.00 per dispatched call, increased from \$16.00 per**  
10 **dispatched call, and to execute a new Emergency Dispatch Services Agreement for the**  
11 **time period October 1, 2003 to September 30, 2004 which is identical to the previous**  
12 **agreement except for the price increase; and**

13 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have**  
14 **reviewed the proposed agreement and recommend approval by the Legislative**  
15 **Council.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
17 **the Emergency Dispatch Services Agreement with Drexel Heights Fire District**  
18 **substantially in the form attached hereto, and authorizes the Chairwoman of the**  
19 **Tohono O'odham Nation to execute it and any further amendments extending the**  
20 **term of the agreement.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
22 **of JANUARY, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
