**RESOLUTION NO. 04-007**

1 **WHEREAS, the Tohono O'odham Nation successfully operates a program for the Elders of the**  
2 **Nation; and**

3 **WHEREAS, funding for the operations of the Senior Services Program is possible in part by Title**  
4 **VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, the Elderly Program, Title VI, Part C, Native American Family Caregiver Support**  
6 **Program budget is amended to reflect the Notification of Grant Award, as follows:**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup> Day**  
28 **of JANUARY, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0-**  
29 **AGAINST; 166.3 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**


