

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Modification of the FY 2004 Budget passed by Resolution 2003-445 pertaining to  
the Authorization to Expend carryover Indian Health Service funds from FY 2004  
IHS Account 11-5016 - Water Resources Study Program)**

**RESOLUTION NO. 04-010**

1 **WHEREAS, on September 30, 2003, Resolution 2003-445 was passed by the Tohono O'odham**  
2 **Legislative Council authorizing funds to be expended during the Fiscal Year 2004**  
3 **from the Nation's, TOUA, and Water Resources Study Program Memorandum of**  
4 **Agreement Account 11-5016 in the amount of \$17,086.98; and**

5 **WHEREAS, in December 2003, the Grants and Contracts Department of the Tohono O'odham**  
6 **Nation calculated the accumulated savings in Fiscal Year 2003 in the Nation's, TOUA,**  
7 **and Water Resources Study Program Memorandum of Agreement Account 11-5016**  
8 **in the amount of \$24,610.31; and**

9 **WHEREAS, the Water Resources Study Program has proposed a budget amendment in Fiscal Year**  
10 **2004 in the amount of \$24,610.31 to increase its budget line items for Program**  
11 **Supplies, and Indirect Costs, while decreasing its budget line items for Salaries and**  
12 **Fringe Benefits; and**

13 **WHEREAS, this budget amendment and savings proposal has been reviewed by the Water**  
14 **Resources Committee and the Budget and Finance Committee and is recommended**  
15 **for approval by the Legislative Council.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
17 **carryover of savings IHS funds provided by the Nation's Memorandum of Agreement**  
18 **with IHS for the Water Resources Study Program in the total amount of \$24,610.31.**

19 **BE IT FINALLY RESOLVED that the budget of \$24,610.31 for the Water Resources Study Program in**  
20 **fiscal year 2004 is approved in accordance with the budget amendment attached**  
21 **hereto.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>, Day**  
23 **of JANUARY, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
28 **Stat. 984).**
