

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Linda D. Carlos to the Tohono O'odham Judicial Court Bench)**

**RESOLUTION NO. 04-019**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint judges**  
2 **to the Tohono O'odham Judicial Court pursuant to Section 3 of Article VIII of the**  
3 **Constitution of the Tohono O'odham Nation, ("Constitution") which states, "The**  
4 **Tohono O'odham Courts shall be courts of record and shall consist of at least six (6)**  
5 **judges appointed by the Tohono O'odham Council."; and**

6 **WHEREAS, the Judiciary Committee, having legislative oversight of matters pertaining to the**  
7 **Tohono O'odham Judicial Court, has accepted and reviewed each judicial candidate's**  
8 **application packet and background information; and**

9 **WHEREAS, the Judiciary Committee has interviewed each judicial candidate who has submitted**  
10 **a complete application and who has appeared before the Committee; and**

11 **WHEREAS, the Legislative Council has likewise interviewed and considered each judicial**  
12 **candidate appearing before the Council; and**

13 **WHEREAS, in accordance with its Judicial Appointment Procedure and its constitutionally vested**  
14 **authority, the Council has voted to appoint Linda D. Carlos as a Tohono O'odham**  
15 **Judicial Court judge for a six (6) year term effective February 1, 2003.**

16 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that**  
17 **it hereby appoints Linda D. Carlos as a Tohono O'odham Judicial Court judge for a six**  
18 **(6) year term effective February 1, 2003 and expiring February 1, 2009.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
20 **of JANUARY, 2004 at a meeting at which a quorum was present with a vote of 2,100.5 FOR; 529.2**  
21 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (a) of Article VI and Article III Section 3 of the Constitution of the Tohono O'Odham**  
23 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
24 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
25 **of the Act of June 18, 1934 (48 Stat. 984).**


