

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and authorizing the use of Gaming Savings funds on the Purchase of the
Roberts Property for the Hia-Ced O'odham by Resolution No. 03-218 to be utilized
for the Hia-Ced O'odham Planning and Development Budget)

RESOLUTION NO. 04-021

1 **WHEREAS, the Tohono O'odham Legislative Council did pass Resolution No. 03-218 approving**
2 **the land acquisition of the Roberts Property by the Tohono O'odham Nation for a Hia-**
3 **Ced O'odham land base and authorized the utilization of Gaming Savings funds in the**
4 **amount of \$1.8 million dollars to purchase the land base; and**

5 **WHEREAS, the Roberts Property land acquisition was finalized on October 2, 2003 at which time**
6 **the Tohono O'odham Nation purchased the property in the amount of \$1.5 million**
7 **dollars on behalf of the Hia-Ced O'odham; and**

8 **WHEREAS, Resolution No. 03-218 states that any funds remaining be held in an investment**
9 **savings account to fund any unforeseen expenses for the Roberts Property, and that**
10 **this funding be for this sole purpose; and**

11 **WHEREAS, the Hia-Ced O'odham Advisory Committee recognizes the need to continue to**
12 **complete Phase I of the Land Acquisition, including to put the land in trust and to**
13 **begin Phase II for Community Planning and Development requesting the Legislative**
14 **Council approval for a budget that supports the new land base acquisition for the**
15 **Hia-Ced O'odham; and**

16 **WHEREAS, the Hia-Ced O'odham Advisory Committee requests to utilize a portion of the**
17 **remaining \$1.8 million dollars (\$288,855.54) from Resolution No. 03-218 in the**
18 **amount of \$73,203.48 to address immediate needs identified and to initiate the**
19 **community planning and development process for the Hia-Ced O'odham.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
21 **support and approve the Hia-Ced O'odham Planning and Development Budget**
22 **request in the amount of \$73,203.48 to be administered by the Hia-Ced O'odham**
23 **Program in collaboration with the Hia-Ced O'odham Advisory Committee for the**
24 **planning and development of the newly acquired land base.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH, Day**
26 **of JANUARY, 2004 at a meeting at which a quorum was present with a vote of 1,620.0 FOR; 834.3**
27 **AGAINST; 175.4 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**




