

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying the Appointment of Lucille Lopez as the Acting Legislative Council Secretary)**

LEGISLATIVE ORDER NO. 04-038

1 **WHEREAS, on August 04, 2003 the Legislative Council did appoint Vivian Hedrington as the**
2 **Tohono O'odham Legislative Council Secretary until June 2005 (Legislative Order No.**
3 **03-344); and**

4 **WHEREAS, on February 09, 2004, the Tohono O'odham Legislative Council did re-visit the**
5 **appointment to discuss the six (6) month evaluation; and**

6 **WHEREAS, by Legislative Order No. 04-031, the Tohono O'odham Legislative Council rescinded**
7 **Legislative Order No. 03-344 (Certifying the Appointment of Vivian Hedrington as**
8 **Legislative Council Secretary).**

9 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
10 **certifies the appointment of Lucille Lopez as Acting Legislative Council Secretary**
11 **from February 11, 2004 through June 2005 or until such a time when an appointment**
12 **for Legislative Council Secretary is made by the Legislative Council.**



15 **FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 1,460.45 FOR; 372.85**
16 **AGAINST; 796.4 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
