

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Revising the FY 2004 Projected Revenues in the amount of \$48,219,656)**

**RESOLUTION NO. 04-041**

1 **WHEREAS, the Budget and Finance Committee, the Chairwoman of the Nation, and the Chief**  
2 **Judge reviewed the revenue projection and available revenues for FY 2004; and**

3 **WHEREAS, the Budget and Finance Committee, the Chairwoman of the Nation, and the Chief**  
4 **Judge recommended and the Tohono O'odham Legislative Council approved**  
5 **Resolution No. 03-409 approving FY 2004 projected revenues in the amount of**  
6 **\$39,296,219; and**

7 **WHEREAS, the Tohono O'odham Legislative Council approved Resolution No. 03-564, Approving**  
8 **the Gaming Revenue Distribution Formula Authorized by Resolution No. 94-098; and**

9 **WHEREAS, based on the approval of Resolution No. 03-564, the newly established projected**  
10 **revenue for FY 2004 is \$48,219,656.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **approves the attached revised projected revenues in the amount of \$48,219,656 for**  
13 **the purpose of funding the FY 2004 general fund budgets of the Tohono O'odham**  
14 **Nation for a twelve-month period based on status-quo levels, resulting in budgets**  
15 **funded for FY 2004 ending on September 30, 2004.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
17 **of FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
20 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**
