

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 03-424 to provide for the remaining six-month Executive Branch**  
**Fiscal Year 2004 Budgets and Appropriating Funds in the amount of \$18,582,617.40)**

RESOLUTION NO. 04-042

1 **WHEREAS, the Executive Branch has prepared and presented its fiscal year 2004 budget to the**  
2 **Tohono O'odham Legislative Council; and**

3 **WHEREAS, Resolution No. 03-409 was amended to provide for projected revenues in the amount**  
4 **of \$48,219,656 and to fund budgets of the Tohono O'odham Nation for a twelve-month**  
5 **period based on status-quo levels of FY 2003; and**

6 **WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 03-424 approve and**  
7 **appropriate \$18,582,617.40 for Executive Branch operations for the period to expire**  
8 **March 30, 2004; and**

9 **WHEREAS, the Executive Branch FY 2004 budget is for the period beginning October 1, 2003**  
10 **through September 30, 2004.**


11 **NOW, THEREFORE, BE IT RESOLVED that Resolution No. 03-424 is amended to fund regular**  
12 **department and program operations for a twelve-month period to expire on**  
13 **September 30, 2004.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Executive Branch**  
15 **Fiscal Year 2004 budget is hereby approved and it does hereby appropriate**  
16 **\$37,165,234.80 for Executive Branch operations.**

17 **BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend these funds approved**  
18 **and appropriated pursuant to the budgets attached and referenced in Resolution No.**  
19 **03-424 for a twelve-month period to expire September 30, 2004.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
21 **of FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 2,355.7 FOR; 274.0**  
22 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


