

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Carmelita Mattias to the Tohono O'odham Enrollment Committee)**

RESOLUTION NO. 04-051

1 WHEREAS, the Ordinance for the Tohono O'odham Nation regulating enrollment in the Tohono  
2 O'odham Nation, Ordinance No. 5-81, as amended, calls for the appointment of  
3 committee members to the Tohono O'odham Enrollment Committee; and

4 WHEREAS, the Chairwoman of the Nation has appointed Carmelita Mattias to serve as a member  
5 of the Tohono O'odham Enrollment Committee; and

6 WHEREAS, Carmelita Mattias agrees to serve as a member of the Tohono O'odham Enrollment  
7 Committee.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the  
9 appointment of Carmelita Mattias to serve as a member of the Tohono O'odham  
10 Enrollment Committee. Mrs. Mattias' term shall commence January 1, 2003, and  
11 shall expire on January 1, 2006.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day  
13 of FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 1,556.85 FOR; 647.65  
14 AGAINST; -0- NOT VOTING; and 425.2 [05] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).


