1	WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program
2	is not ethically allowed to handle in the increasing needs of tribal members for legal
3	representation in civil and criminal matters; and
4	WHEREAS, the Advocate Program wishes to retain David M. Juarez and Lawrence O. Boswell to
5	be appointed to represent clients with conflict of interest who can not be represented
6	by the Nation's Advocate Program; and
7	WHEREAS, the Advocate Program has presented a contract for David M. Juarez and Lawrence O.
8	Boswell which confirms and ratifies the terms and conditions related to their
9	services, a copy of which is attached; and
10	WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of
11	an Attorney Contract with David M. Juarez and Lawrence O. Boswell on such terms.
12	NOW, THEREFORE, BE IT RESOLVED THAT:
13	1. The Tohono O'odham Legislative Council ratifies and approves the conflict
14	Attorney Contracts for David M. Juarez and Lawrence O. Boswell in the forms
15	attached hereto for the period of October 1, 2003 through March 31, 2004 in the
16	amount not to exceed \$37,500.00 per contract or \$75,000.00 total.
17	2. Funding for the Conflict Attorney Contracts for David M. Juarez and Lawrence O.
	Boswell shall be provided under the operating budget of the Advocate Program
