1 **WHEREAS, the Baboquivari District Council met on Tuesday, September 16, 2003 and did review**
2 **the Baboquivari District savings account; and**

3 **WHEREAS, six (6) district council representatives are in agreement to utilize some of the savings**
4 **to pay for two (2) meetings each month at \$100.00 per meeting; and**

5 **WHEREAS, the six (6) representatives have agreed to take Twenty Eight Thousand Eight Hundred**
6 **Dollars and No Cents (\$28,800.00) from the district savings account #68-01-101-**
7 **1067509,**

8 **JUSTIFICATION: to pay for the district council per-diem for budget year 2004; and**

9 **WHEREAS, Twenty Eight Thousand Eight Hundred Dollars (\$28,800.00) will be added to the**
10 **existing line item 640.32 Committee Fees increasing the annual FY 2004 District**
11 **Administration budget to Two Hundred Seventy Six Thousand Forty Four Dollars and**
12 **Twelve Cents (\$276,044.12); and**

13 **WHEREAS, any changes in the justifications, additions and/or transfer of funds between budget**
14 **line items are to be reviewed and approved by the Tohono O'odham Legislative**
15 **Council.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
17 **for Twenty Eight Thousand Eight Hundred Dollars and No Cents (\$28,800.00) to be**
18 **drawn against the Baboquivari District savings account #68-01-101-1067509 and**
19 **added to the existing line item 640.32 Committee Fees increasing the annual FY 2004**
20 **Baboquivari District Administration budget by Twenty Eight Thousand Eight**
21 **Hundred Dollars and No Cents (\$28,800.00).**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
24 **of FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 2,375.7 FOR; -0-**
25 **AGAINST; 87.70 NOT VOTING; and 166.3 [03] ABSENT, pursuant to the powers vested in the Council**
26 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**




