

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
(Setting February 20, 2004 Special Session to address the Lobbyist Contract)

LEGISLATIVE ORDER NO. 04-058

1 WHEREAS, Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation empowers  
2 the Legislative Council "To establish rules and procedures to regulate all meetings  
3 of the Tohono O'odham Council, standing committees, boards, and special  
4 committees"; and

5 WHEREAS, on February 12, 2004 the Tohono O'odham Legislative Council did interview the  
6 lobby firm of Holland & Knight; and

7 WHEREAS, the Tohono O'odham Legislative Council by Resolution No. 04-045 authorized the  
8 Appropriations Committee and the Executive Office to negotiate a contract with the  
9 firm Holland & Knight; and

10 WHEREAS, it is necessary for a lobby contract to be executed in order for the lobbying firm to  
11 proceed; and

12 WHEREAS, the Appropriations Committee requests that a special session be held on February  
13 20, 2004 to address the lobbyist contract.

14 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby  
15 schedules a Special Session for February 20, 2004 to address the lobbyist contract.

16 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day of  
17 FEBRUARY, 2004 at a meeting at which a quorum was present with a vote of 2,248.55 FOR; 126.80  
18 AGAINST; 88.05 NOT VOTING; and 166.3 [03] ABSENT, pursuant to the powers vested in the Council  
19 by Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
20 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
22 18, 1934 (48 Stat. 984).
