

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Clarence Miguel to the Tohono O'odham Enrollment Committee)**

RESOLUTION NO. 04-064

1 **WHEREAS, the Ordinance for the Tohono O'odham Nation regulating enrollment in the Tohono**
2 **O'odham Nation, Ordinance No. 5-81, as amended, calls for the appointment of**
3 **committee members to the Tohono O'odham Enrollment Committee; and**

4 **WHEREAS, the Chairwoman of the Nation has appointed Clarence Miguel to serve as a member**
5 **of the Tohono O'odham Enrollment Committee; and**

6 **WHEREAS, Clarence Miguel agrees to serve as a member of the Tohono O'odham Enrollment**
7 **Committee.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
9 **appointment of Clarence Miguel to serve as a member of the Tohono O'odham**
10 **Enrollment Committee. Mr. Miguel's term shall commence January 1, 2004, and shall**
11 **expire on January 1, 2007.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01ST Day**
13 **of MARCH, 2004 at a meeting at which a quorum was present with a vote of 1,997.8 FOR; 631.9**
14 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


