

NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant is eligible for enrollment as a member of the Tohono O'odham Nation under Section 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that their application is approved, as herein above indicated.

BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono O'odham Nation reduce this final determination in writing regarding each of the foregoing applications for enrollment in accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give notice of this Council's determination in accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the names of each applicant upon the membership roll of the Tohono O'odham Nation in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 01st Day of MARCH, 2004 at a meeting at which a quorum was present, and by a vote of 1,260.15 FOR; 1,369.55 AGAINST; -0- NOT VOTING; and [01] ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'odham Nation.
