## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Limited Waiver of Sovereign Immunity in Tohono O'odham Farming Authority 2004 Financing Arrangements)

1	WHEREAS,	the Tohono O'odham Farming Authority ("TOFA") has negotiated with ACCO Finance
2		Co. ("AFC") amendments to:
3		(1) the TOFA Multiple Year Revolving Line of Credit Loan Agreement, executed on
4		November 27, 2000, in the amount of \$3,166,143, as amended on December 3,
5		2002, February 6, 2003, March, 2003, and April 15, 2003 ("Crop Loan Agreement"),
6		and the related TOFA Multiple Year Revolving Secured Promissory Note; and
7		(2) the TOFA Multiple Year Revolving Line of Credit Loan Agreement, executed on
8		November 27, 2000, in the amount of \$300,000 and as amended on April 25, 2002
9		and April 15, 2003 ("Vegetable Loan Agreement"), and the related TOFA Multiple
10		Year Revolving Secured Promissory Note; and
11	WHEREAS,	TOFA has negotiated with AFC the Equipment Loan Agreement, in the amount of
12		\$750,000, and the related Promissory Note; and
13	WHEREAS,	as amended, the Crop Loan Agreement and the Vegetable Loan Agreement will
14		require that TOFA execute the Anderson-Clayton Business Agreement with Anderson
15		Clayton Corp. related to ginning of seed cotton grown by TOFA during the 2004 crop
16		year (the "Business Agreement"); and
17	WHEREAS,	as amended, the Crop Loan Agreement, Vegetable Loan Agreement, the Equipment
18		Loan Agreement, and the Business Agreement each contain a limited waiver of TOFA's
19		sovereign immunity with respect to disputes arising thereunder; and
20	WHEREAS,	the  amended  Crop  Loan  Agreement, the  amended  Vegetable  Loan  Agreement, and  the
21		Equipment Loan Agreement require that TOFA deliver to AFC the Non-Disturbance
22		Agreement executed by the Nation; and
23	WHEREAS,	on December 5, 2000, the Tohono O'Odham Nation Legislative Council adopted the
24		attached Resolution No. 2000-559; and
25	WHEREAS,	on April 14, 2003, the Tohono O'Odham Nation Legislative Council adopted the
26		attached Resolution No. 03-157; and
27	WHEREAS,	Resolution No. 2000-559 and Resolution No. 03-157 approved limited waivers of
28		sovereign immunity as provided in the Crop Loan Agreement, Vegetable Loan
29		Agreement, and the Business Agreement, and authorized the Nation's Chairwoman

4	Nation, is authorized and directed to execute the Non-Disturbance Agreement
5	in substantially the form and on the terms set forth in the attached Non-
6	Disturbance Agreement.
