

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Acceptance of Assistance Amendment #X-98933601-5 Border Project-Environmental Coordinator Program)**

RESOLUTION NO. 04-070

1 **WHEREAS, the US EPA has offered an extension of the Border Project until September 30, 2004**  
2 **(Grant Assistance Amendment #X-98933601-5); and**

3 **WHEREAS, there is an ongoing need for the Tribal Border Environmental Coordination Project**  
4 **to develop environmental infrastructure, identify and update specific border issues;**  
5 **and**

6 **WHEREAS, there is a savings available to continue the Tribal Border Environmental**  
7 **Coordination Project; and**

8 **WHEREAS, the program period has been modified to June 30, 1999 - September 30, 2004.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
10 **Grant Assistance Amendment #X-98933601-5, extending the Border Project -**  
11 **Environmental Coordinator Program to June 30, 1999 through September 30, 2004.**

12 **BE IT FURTHER RESOLVED that the TON EPA is authorized to expend all available funds awarded**  
13 **pursuant to Grant Assistance Amendment #X-98933601-5.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
15 **Nation's Official, to wit: the Chairwoman, or her designated official are hereby**  
16 **authorized to negotiate and execute the grant, provided however, that any**  
17 **amendments affecting the funds or funding levels of the grant shall be submitted for**  
18 **further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 01<sup>ST</sup> Day**  
20 **of MARCH, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
23 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
24 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
25 **Stat. 984).**
