

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2005 Title VI, Part C Native American Family Caregiver Support
Program Budget)**

RESOLUTION NO. 04-075

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the Elders of the**
2 **Nation; and**

3 **WHEREAS, funding for the operation of the Senior Services Program has been made possible in**
4 **part by Title VI of the Older American's Act of 1978 as amended; and**

5 **WHEREAS, Title VI, Part C Native American Family Caregiver Support Program has prepared a**
6 **budget of \$49,630 for the third and final year of a three-year project; and**

7 **WHEREAS, the third and final year of the three-year project covers April 1, 2004 through March**
8 **30, 2005 for the Title VI, Part C Native American Family Caregiver Support Program;**
9 **and**

10 **WHEREAS, the Title VI, Part C Native American Family Caregiver Support Program is requesting**
11 **approval of the Fiscal Year 2005 Budget of \$49,630 and the expending of funds from**
12 **April 01, 2004 through March 30, 2005.**


13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative that it hereby approves:**

14 **1. The FY 2005 Title VI, Part C Native American Family Caregiver Support Program**
15 **Budget of \$49,630 and the expending of funds from April 01, 2004 through March**
16 **30, 2005.**

17 **2. The Tohono O'odham Nation officials, to wit: The Chairwoman is hereby**
18 **authorized to negotiate and execute the grant, provided however, that any**
19 **amendments affecting the funding or funding levels of this contract shall be**
20 **submitted for further prior approval by this Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 02ND. Day**
22 **of MARCH, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
24 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**
