9		2003 to March 31, 2004; and
10	WHEREAS,	pursuant to Resolution No. 04-042, the Legislative Council authorized funding of the
11		Office of Attorney General and other Executive Branch programs for the twelve-
12		month period ending September 30, 2004; and
13	WHEREAS,	additional funding is required to continue representation of the Nation by the
14		Attorneys under the Attorney Contract; and
15	WHEREAS,	the Attorney General has proposed Amendment No. 1 to the Attorney Contract which
16		increases the Contract amount from \$60,000 to \$120,000 and extends the Contract
17		term through September 30, 2004; and
18	WHEREAS,	the budget of the Office of Attorney General (01-1031-810) has sufficient funds for the
19		increased Contract amount; and
20	WHEREAS,	the Domestic Affairs and Budget & Finance Committees recommend approval by the
21		Legislative Council of Amendment No. 1 to the Attorney Contract.
22	NOW, THER	REFORE, BE IT RESOLVED THAT:
23		1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the
24		Attorney Contract, in the form attached hereto, which increases the Contract
25		$amount to \$120,\!000\ and\ extends\ the\ Contract\ term\ through\ September\ 30,2004.$

27		Attorney General (01-1031-810).
