

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Amending Resolution No. 03-456 to Provide a Six Month Fiscal Year 2004 Judicial Branch**  
**Budget and Appropriating Funds in the Amount of \$2,373,178.76)**

RESOLUTION NO. 04-092

1 **WHEREAS, the Tohono O'odham Judicial Branch has prepared and presented its fiscal year 2004**  
2 **budget to the Tohono O'odham Legislative Council; and**

3 **WHEREAS, Resolution No. 03-409 was amended to provide for projected revenues in the amount**  
4 **of \$48,219,656.00 and to fund budgets of the Tohono O'odham Nation for a twelve**  
5 **month period based on the status quo levels of FY 2003; and**

6 **WHEREAS, the Tohono O'odham Legislative Council enacted Resolution No. 03-457, approving**  
7 **and appropriating a six month budget in the amount of \$2,373,178.77 for the Judicial**  
8 **Branch operations which expires on March 31, 2004; and**

9 **WHEREAS, the Judicial Branch FY 2004 budget is for the period beginning October 1, 2003**  
10 **through September 30, 2004.**

11 **NOW, THEREFORE, BE IT RESOLVED that resolution No. 03-456 is amended to fund the Judicial**  
12 **Branch operations for a twelve-month period, which will expire on September 30,**  
13 **2004.**

14 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Judicial Branch**  
15 **FY 2004 budget is hereby approved and it does thereby appropriate the balance of the**  
16 **Tohono O'odham Judiciary budget in the amount of \$2,373,178.76 for the Judicial**  
17 **Branch operations.**

18 **BE IT FINALLY RESOLVED that the Judicial Branch is authorized to expend these funds approved**  
19 **and appropriated in accordance with the attached budget and is referenced in**  
20 **Resolution No. 03-456 for a twelve-month period, which will expire September 30,**  
21 **2004.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
23 **of MARCH, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0-**  
24 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
25 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
26 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
28 **18, 1934 (48 Stat. 984).**
