

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District FY 2004 Budget Amendment #1 for \$695,288.83)**

RESOLUTION NO. 04-093

1 **WHEREAS, the Tohono O'odham Legislative Council did convene on March 01, 2004 to address**
2 **issues pertaining to the Nation; and**

3 **WHEREAS, the Gu Achi District Fiscal Year 2004 Budget was approved for 6 months, by the Gu**
4 **Achi District Council and the Tohono O'odham Legislative Council; and**

5 **WHEREAS, the resolution approving the Gu Achi District FY 2004 Budget approved that any**
6 **savings balances from the FY 2003 and any other allocations be deposited into the**
7 **District's Investment Account with Wachovia Securities; and**

8 **WHEREAS, the resolution approving the Gu Achi District budget states that the Gu Achi District**
9 **will re-submit their FY 2004 Budget to the Legislative Council within the six month**
10 **period for approval to the remaining FY 2004; and**

11 **WHEREAS, the Gu Achi District Finance Committee, the District Chairman and the Treasurer of**
12 **the district have reviewed and recommended changes to the budget for the**
13 **remaining 6 month of the FY 2004; and**

14 **WHEREAS, the Gu Achi District reserves the right to modify its FY 2004 Budget at any time as**
15 **needed but any amendments to the budget shall be approved by the Tohono O'odham**
16 **Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **Gu Achi District FY 2004 Budget Amendment #1 for the amount of \$695,288.83.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day**
20 **of MARCH, 2004 at a meeting at which a quorum was present with a vote of 1,730.6 FOR; 182.05**
21 **AGAINST; 717.05 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**
