

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-023, "Approving the Nation's Officials to Initiate the Process of
Negotiation for Purchase of Lands to Accommodate Growth for the Florence Community)

RESOLUTION NO. 04-094

1 WHEREAS, the Gu Achi District Council established a quorum at a regularly scheduled meeting
2 on February 27, 2004 in the community of Santa Rosa to address matters pertaining
3 to the district; and

4 WHEREAS, Gu Achi District Resolution No 1203-383 and Tohono O'odham Legislative Council
5 Resolution No. 04-023 was approved; and

6 WHEREAS, the acreage was misquoted and the figure must be changed from '64' to
7 'approximately 88' to include the entire acreage.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
9 amendment to Resolution No. 04-023 changing the figure to '64' to 'approximately
10 88'.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH. Day
12 of MARCH, 2004 at a meeting at which a quorum was present with a vote of 2,415.1 FOR; -0-
13 AGAINST; 214.6 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by
14 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
15 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
16 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
17 Stat. 984).


