

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Certifying the Election of Isidro Lopez as Chairman of the Tohono O'odham**  
**Legislative Council)**

**LEGISLATIVE ORDER NO. 04-107**

1 **WHEREAS, during the April 12, 2004 General Session, the Legislative Council did by Legislative**  
2 **Order No. 04-105 rescind Legislative Order No. 03-238, "Certifying the Election of**  
3 **Dennis Ramon as Chairman of the Tohono O'odham Legislative Council"; and**

4 **WHEREAS, the Constitution of the Tohono O'odham Nation empowers the Legislative Council**  
5 **to "appoint, or provide for the appointment of, and prescribe the duties and powers**  
6 **of committees, boards, officers . . ." (Constitution, Article VI, Section 1(b)); and**

7 **WHEREAS, each Representative did cast their votes for one of the candidates nominated for said**  
8 **office; Councilman Isidro Lopez received 1,361.65 votes; Councilman Timothy**  
9 **Joaquin received 175.4 votes; Councilwoman Evelyn Juan received 318.8 votes;**  
10 **Councilwoman Delma Garcia received 773.85 votes; and Councilwoman Darlene**  
11 **Andrew received 0 votes; and**

12 **WHEREAS, Councilman Isidro Lopez having received a majority of the votes cast was declared**  
13 **as Legislative Chairman Elect.**

14 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
15 **certifies the election of Isidro Lopez as Chairman of the Tohono O'odham Legislative**  
16 **Council.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day of**  
19 **APRIL, 2004 at a meeting at which a quorum was present with a vote of 1,425.6 FOR; 945.20**  
20 **AGAINST; 258.9 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
24 **18, 1934 (48 Stat. 984).**
