31 **Section 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation,**
32 **and that their application is approved, as herein above indicated.**

33 **BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono**
34 **O'odham Nation reduce this final determination in writing regarding each of the**
35 **foregoing applications for enrollment in accordance with Section 1(a) of Article**
36 **XIII of the Enrollment Ordinance; give notice of this Council's determination in**
37 **accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place**
38 **the names of each applicant upon the membership roll of the Tohono O'odham**
39 **Nation in accordance with Sections 2 and 3 of Article X of the Enrollment**
40 **Ordinance.**

41 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 12TH Day**
42 **of APRIL 2004 at a meeting at which a quorum was present with a vote of 1,987.75 FOR; 319.4**
43 **AGAINST; 322.55 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
44 **Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**
45 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
46 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**
47 **of the Act of June 18, 1934 (48 Stat. 984).**
