

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Nation Employment & Training – State of Arizona WIA**  
**Contract Amendment and Budget Modification #2 PY 2002)**

**RESOLUTION NO. 04-113**

1 **WHEREAS, the original funding amount for the State of Arizona – Contract amount was**  
2 **\$255,869.00 implemented on July 1, 2002; and**

3 **WHEREAS, the State of Arizona requires the Dislocated Worker Funds (Administrative Budget**  
4 **Account number 12-1644 and Program Budget Account Number 12-1643) to be added**  
5 **to the PY 2002 contract E5703026 in the combined total amount of \$52,999.00; and**

6 **WHEREAS, the State of Arizona increased the Youth Budget (Account Number 12-1602) a**  
7 **combined total amount of \$13,467.00; and**

8 **WHEREAS, the State of Arizona Youth Budget (Account Number 12-1602) adds the line numbers**  
9 **610.00 Work Experience; 620.00 WEX Fringe Benefits and 810.00 professional services;**  
10 **and**

11 **WHEREAS, this budget modification has a total increase of \$66,466.00 for contract #E5703026.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
13 **approve the State of Arizona – Contract #E5703026 Amendment and Budget**  
14 **Modification #2 PY 2002 in the amount of \$322,335.00. 1) The Dislocated Worker**  
15 **Funds Account # 12-1644 and # 12-1643 to be added to the PY 2002 contract E5703026**  
16 **in the combined total amount of 52,999.00. 2) The State of Arizona increases the**  
17 **Youth Budget Account # 12-1602 in the combined total amount of \$13,467.00. 3) The**  
18 **Account # 12-1602 added new line items 610.00 Work Experience; 620.00 WEX Fringe**  
19 **Benefits and 810.00 Professional Service. 4) This budget Amendment and**  
20 **Modification has a total increase of 66,466.00.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**  
23 **execute the contract, provided however, that any amendment affecting the funding**  
24 **or funding levels of this contract shall be submitted for further prior approval by this**  
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
27 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; 166.3**  
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**
