

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the Tohono O'odham Nation Employment & Training – State of Arizona WIA Contract**  
**Amendment and Budget Modification #1 PY 2003)**

RESOLUTION NO. 04-114

1 WHEREAS, the original funding amount for the State of Arizona – Contract amount was  
2 \$283,279.00 implemented on July 1, 2003; and

3 WHEREAS, the State of Arizona requires the Dislocated Worker Funds (Administrative Budget  
4 Account number 12-1644 and Program Budget Account Number 12-1643) to be added  
5 to the PY 2002 contract E5703026 in the combined total amount of \$52,999.00 and  
6 removed from PY 2003 contract E5704026; and

7 WHEREAS, the State of Arizona decreased the final allocation to the Tohono O'odham Nation in  
8 the amount of \$39,593.00; and

9 WHEREAS, this budget modification has a total decrease of \$92,592.00 for contract #E5704026.

10 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
11 approve the State of Arizona – Contract #E5704026 Amendment and Budget  
12 Modification #1 PY 2003 in the amount of \$190,687.00. The Dislocated Worker  
13 Funds Account # 12-1644 and # 12-1643 to be added to the PY 2002 contract  
14 E5703026 in the combined total amount of 52,999.00. And removed from PY 2003  
15 Contract E5704026 State of Arizona decreases the final allocation to the Tohono  
16 O'odham Nation in the amount of 39,593.00. The budget amendment and budget  
17 modification has a total decrease of 92,592.00 for contract # E5704026.

18 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono  
19 O'odham Nation's Officials, to wit; the Chairwoman is hereby authorized to  
20 negotiate and execute the contract, provided however, that any amendment  
21 affecting the funding or funding levels of this contract shall be submitted for  
22 further prior approval by this Council.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day  
24 of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; 166.3  
25 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
26 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
27 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
28 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
29 Stat. 984).
