**RESOLUTION NO. 04-115**

1 **WHEREAS, the funding amount for the Department of Health and Human Services – Native**  
2 **Employment Works Program Year 2000 is \$150,868.00; and**


3 **WHEREAS, this modification reduces the Administrative Budget (11-1679) \$26.87 and moves**  
4 **this balance to Direct Services (11-1680).**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
6 **approve the Department of Health and Human Services – Native Employment**  
7 **Works Program Year 2000 Budget Modification #4 in the amount of \$ 150,868.00**  
8 **expiring June 30, 2004. This modification reduces the Administrative Budget (11-**  
9 **1679) \$26.87 and moves this balance to Direct Services (11-1680).**

10 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
11 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**  
12 **execute the contract, provided however, that any amendment affecting the funding**  
13 **or funding levels of this contract shall be submitted for further prior approval by this**  
14 **Council.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup>. Day**  
16 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
17 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


