

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Employment & Training – Department of Health and Human Services – Native Employment Works PY 2002 Budget Modification #1)

RESOLUTION NO. 04-117

1 WHEREAS, the funding amount for the Department of Health and Human Services – Native
2 Employment Works Program Year 2002 is \$150,868.00; and

3 WHEREAS, this modification reduces the Administrative Budget (11-1601) \$3,131.21 and moves
4 this balance to Direct Services (11-1602).

5 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
6 approve the Department of Health and Human Services – Native Employment Works
7 Program Year 2002 Budget Modification #1 in the amount of \$150,868.00 expiring
8 June 30, 2005. This modification reduces the Administrative Budget (11-1601)
9 \$3,131.21 and moves this balance to Direct Services (11-1602).

10 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono
11 O'odham Nation's Officials, to wit; the Chairwoman is hereby authorized to
12 negotiate and execute the contract, provided however, that any amendment
13 affecting the funding or funding levels of this contract shall be submitted for
14 further prior approval by this Council.

15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day
16 of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,463.4 FOR; -0- AGAINST;
17 166.3 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)
18 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
19 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
20 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
