

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the Food Distribution Program Nutrition Education Funding Budget Account**  
**Number 11-1316)**

**RESOLUTION NO. 04-118**

1 **WHEREAS, the Tohono O'odham Nation, Department of Human Services is presently operating**  
2 **the Family Assistance Division, Food Distribution Program, under an FY 2004 Grant**  
3 **with the United States Department of Agriculture (USDA); and**

4 **WHEREAS, any amendments affecting the funding or funding levels of the grant shall be**  
5 **submitted for review and approval by the Tohono O'odham Legislative Council; and**


6 **WHEREAS, the Food Distribution Program has submitted the Nutrition Education funding**  
7 **budget in the amount of \$612.00 for FY 2004, effective date October 01, 2003 for review**  
8 **and approval, which reflects a reduced funding from FY 2003 (\$1,846.00).**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 10           **1. It hereby approves and authorizes the Nutrition Education Budget in the amount**  
11           **of \$612.00 for FY 2004 and authorizes expenditures in accordance with the**  
12           **attached budget; and**
- 13           **2. The Tohono O'odham Nation's Officials to wit: the Chairwoman is hereby**  
14           **authorized to negotiate and execute the grant.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
16 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
17 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
