

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2004 Arizona Long Term Care Services Budget Amendment #1 October 01, 2003**  
**- September 30, 2004)**

**RESOLUTION NO. 04-120**

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State of**  
2 **Arizona to provide Arizona Long Term Care Services (ALTCS) Case Management**  
3 **services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided ALTCS Case Management services since**  
5 **June 1996 and is being reimbursed from the State of Arizona for these services; and**


6 **WHEREAS, the ALTCS program budget, account #14-1416 is amended to utilize identified salaries**  
7 **& fringe benefit savings for other line items created for the Program.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 9           **1. It hereby approves the Arizona Long Term Care Services (ALTCS) Program fiscal**  
10 **year 2004 budget amendment to utilize identified salary & fringe benefit savings**  
11 **for other line items created for the program.**
- 12           **2. The Tohono O'odham Nation's Officials to wit: the Chairwoman and any**  
13 **designated official are hereby authorized to negotiate and execute the grant,**  
14 **provided however, that any amendment affecting the funding or funding levels**  
15 **of this contract shall be submitted for further prior approval by this Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
17 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
19 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
