4		Vassar, Dills, Dawson & Bonfiglio, L.L.C. and Graham & Dunn, P.C. to secure legal						
5		advice and representation in connection with the feasibility of expanding gaming						
6		activities; and						
7	WHEREAS,	each attorney contract was in the amount of \$100,000 for the period from March 1,						
8		2003 through May 1, 2004 and was funded under the line of credit; and						
9	WHEREAS,	the Attorney General recommends approval of the attached Amendment No. 1 to each						
10		attorney contract which would extend the term of the contract through May 1, 2005.						
11	NOW, THEREFORE, BE IT RESOLVED THAT:							
12		1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the						
13		attorney contracts with the law firms of Vassar, Dills, Dawson & Bonfiglio, L.L.C.						
14	and Graham & Dunn, P.C., in the form attached hereto, which extends the term							
15	of each contract through May 1, 2005.							
16		2. The Chairwoman of the Nation is authorized and directed to execute Amendment						
17		No. 1 to each attorney contract.
