6	grant to the Venito Garcia Library and Archives from the Arizona Humanities Counci							
7	for a grant for the amount of \$3,025 with an in-kind contribution of \$4,950, and							
8	authorizes the use of the funds provided by the Venito Garcia Library and Archives,							
9	and waives indirect costs which is a requirement of this particular grant.

11	of <u>APRIL, 2004</u> at a meeting at which a quorum was present with a vote of <u>2,629.7</u> FOR; <u>-0-</u> AGAINST
