

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(ACCEPTING A GENERAL GRANT FOR THE VENITO GARCIA LIBRARY AND ARCHIVES FROM THE
ARIZONA HUMANITIES COUNCIL)

RESOLUTION NO. 04-131


1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Venito Garcia Library and Archives is charged with library development for the**
4 **Tohono O'odham Nation.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts the**
6 **grant to the Venito Garcia Library and Archives from the Arizona Humanities Council**
7 **for a grant for the amount of \$3,025 with an in-kind contribution of \$4,950, and**
8 **authorizes the use of the funds provided by the Venito Garcia Library and Archives,**
9 **and waives indirect costs which is a requirement of this particular grant.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
11 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
12 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
13 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
14 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
15 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
