1	WHEREAS,	the Tohono O'odham Nation operates 24-hour group homes for Nation's children who								
2		are under the care, custody and control of the Nation's Department of Human								
3		Services; and								
4	WHEREAS,	the Nation through its Public Law 93-638 Master Contract with the U.S. Department								
5		of Interior, Bureau of Indian Affairs, receives federal funds to operate its group								
6		homes for children; and								
7	WHEREAS,	25 Code of Federal Regulations Part 20, entitled, "Financial Assistance and Social								
8		Services Programs," sets forth a funding requirement that group homes for children								
9		be licensed; and								
10	WHEREAS,	the establishment of a group home licensing review team would facilitate licensing								
11		of the group homes for children under the care, custody and control of the								
12		Department of Human Services, which licences will be issued by the Chairperson of								
13		the Nation; and								
14	WHEREAS,	the Department of Human Services has presented a proposal to the Health and								
15		Human Services Committee for the establishment of a group home licensing review								
16		team, which committee recommends approval by the Legislative Council.								
17	NOW, THER	NOW, THEREFORE, BE IT RESOLVED THAT:								
18		1. A Group Home Licensing Review Team ("Review Team") is hereby established for								
19		the purpose of reviewing the licensing of group homes for children under the								
20		care, custody and control of the Department of Human Services.								
21		2. The Chairperson of the Nation is authorized to establish standards for the								
22		licensing of group homes, which standards shall first receive the review and								
23		approval of the Legislative Council Health and Human Services Committee.								
24		3. The Chairperson of the Nation is also authorized to appoint Review Team								
25		members, establish procedures for the functions of the Review Team, and to								
26		issue, deny, suspend, and revoke licenses for the operation of group homes for								
27		children under the care, custody and control of the Department of Human								
28		Services.								
29		4. The Review Team shall:								
30		A. Be composed of three (3) members appointed by the Chairperson of the

1	Nation, with members serving 3-year staggered terms, with one 1-year									
2	term, one 2-year term, and one 3-year term at the Review Team's beginning

4	B. Meet as often as required to review and approve application for licensing									
5	group homes.									
6	C. Recommend to the Chairperson of the Nation actions to issue, deny,									
7	suspend, or revoke licenses for the operation of group homes.
