(Approving the appointment of Ms. Muriel J. Segundo as the Executive Director
to the Department of Membership Services)**

RESOLUTION NO. 04-140

1 **WHEREAS, the Constitution of the Tohono O'odham Nation provides the Chairwoman of the**
2 **Tohono O'odham Nation the authority to appoint heads of governmental**
3 **departments with the approval of the Tohono O'odham Legislative Council (Article**
4 **VII, Section 2e); and**

5 **WHEREAS, the Chairwoman of the Tohono O'odham Nation has identified and conducted a**
6 **preliminary interview with the appointee; and**

7 **WHEREAS, Ms. Muriel J. Segundo is qualified to assume the position of Executive Director of the**
8 **Department of Membership Services; and**

9 **WHEREAS, Ms. Muriel J. Segundo has accepted the position and appointment upon approval of**
10 **the Tohono O'odham Legislative Council.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
12 **approve the appointment of Ms. Muriel J. Segundo as the Executive Director of the**
13 **Department of Membership Services.**

14 **BE IT FURTHER RESOLVED that Ms. Muriel J. Segundo shall serve at the pleasure of the**
15 **Chairwoman of the Tohono O'odham Nation.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH Day**
17 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 1,291.55 FOR; 910.6**
18 **AGAINST; 427.55 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
