

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Higher Education Services FY 2004 Budget Modification #1 Account #10-1215)**

**RESOLUTION NO. 04-144**

1 **WHEREAS, the Tohono O'odham Nation through the Higher Education Services Program has**  
2 **been successfully providing counseling and financial assistance to eligible Tohono**  
3 **O'odham to attend Post Secondary Institutes; and**

4 **WHEREAS, the Higher Education Services Program, through the Grants and Contracts Office, has**  
5 **received the BIA's FY 2004 Allocation through Modification #145 in the amount of**  
6 **\$59,025.00 and Modification #150 in the amount of \$641,411.00 a total of \$700,436.00**  
7 **which reflects a decrease in the FY 2004 budget in the amount of \$1,189.00; and**

8 **WHEREAS, the Higher Education Services Program has a savings from Fiscal Year 2003 in the**  
9 **amount of \$50,028.79, which was identified by Grants and Contracts Office; and**

10 **WHEREAS, the FY 2004 Higher Education Services Program modification reflects reducing line**  
11 **items to move to line item 626 (Allowances and Stipends), 720 (Supplies - Office), 812**  
12 **(Public Relations), 860 (Special Activities), 867 (Awards), and 892 (Non-Major Capitol**  
13 **Equipment) to cover cost for continued services; and**

14 **WHEREAS, the FY 2004 Higher Education Services Program modification reflects the change of**  
15 **the indirect cost from 16.7% to 16.69%.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **Higher Education Services Program Budget Modification #1 reflecting the FY 2004**  
18 **Final Allocation of \$700,436.00 and the FY 2003 savings in the amount of \$50,028.79,**  
19 **with the total budget of \$757,530.21.**

20 **BE IT FURTHER RESOLVED that the FY 2004 Higher Education Services Program modification**  
21 **includes a new line item, 892 Non-Major Capitol Equipment in the amount of**  
22 **\$1,708.07.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
24 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
25 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
26 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
