9		amount of \$50,028.79, which was identified by Grants and Contracts Office; and
10	WHEREAS,	the FY 2004 Higher Education Services Program modification reflects reducing line
11		items to move to line item 626 (Allowances and Stipends), 720 (Supplies - Office), 812
12		(Public Relations), 860 (Special Activities), 867 (Awards), and 892 (Non-Major Capitol
13		Equipment) to cover cost for continued services; and
14	WHEREAS,	the FY 2004 Higher Education Services Program modification reflects the change of
15		the indirect cost from 16.7% to 16.69%.

17		Higher Education Services Program Budget Modification #1 reflecting the FY 2004
18		Final Allocation of \$700,436.00 and the FY 2003 savings in the amount of \$50,028.79,
