

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2004 Attorney Contracts for David M. Juarez and Lawrence O. Boswell**  
**to serve as Conflict Attorneys)**

RESOLUTION NO. 04-146

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**  
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**  
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain David M. Juarez and Lawrence O. Boswell to**  
5 **be appointed to represent clients with conflict of interest who can not be represented**  
6 **by the Nation's Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for David M. Juarez and Lawrence O.**  
8 **Boswell which confirms and ratifies the terms and conditions related to their**  
9 **services, a copy of which is attached; and**


10 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**  
11 **an Attorney Contract with David M. Juarez and Lawrence O. Boswell on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 13 **1. The Tohono O'odham Legislative Council ratifies and approves the conflict**  
14 **Attorney Contracts for David M. Juarez and Lawrence O. Boswell in the forms**  
15 **attached hereto for the period of April 1, 2004 through September 30, 2004 in the**  
16 **amount not to exceed \$37,500.00 per contract or \$75,000.00 total.**
- 17 **2. Funding for the Conflict Attorney Contracts for David M. Juarez and Lawrence O.**  
18 **Boswell shall be provided under the operating budget of the Advocate Program**  
19 **for Fiscal Year 2004.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
21 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**  
23 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
