

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 2004 Bureau of Indian Affairs Realty Program Budget Amendment No. 1)**

**RESOLUTION NO. 04-158**

1 **WHEREAS, the Legislative Council through Resolution No. 03-424 authorized the Executive**  
2 **Branch to expend funds for the Realty Program in the amount of \$43,797.00 + Est. IDC**  
3 **\$7,247.30, with a total of \$51,039.96 and;**

4 **WHEREAS, the Executive Branch requests the Legislative Council to amend the budget approved**  
5 **and adjust the amount adding Realty FY 2003 (carry over) of \$37,874.52 plus**  
6 **additional from the BIA savings in Real Estate \$39,285.70 totaling \$77,160.22 plus**  
7 **\$43,797.00 Base Budget + Est. IDC \$15,584.07 Totals to \$136,541.29.**

8 **WHEREAS, the Realty Program in this adjustments is including additional line items:**

9 **700 – Advertisement**

10 **770 – RM Equipment**

11 **892 – Non- Major Capital Equipment**

12 **750 – Major Capital**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council amends Resolution No. 03-424 and**  
14 **approves the adjustment of the budget for the Realty Office from \$51,039.96 to**  
15 **\$136,541.29 by adding carry over funding from FY 2003 Realty Office (carry over) of**  
16 **\$37,874.52 plus additional from the BIA Real Estate \$39,285.70 totaling \$77,160.22**  
17 **plus \$43,797.00 Base Budget + Est. IDC \$15,584.07 Totals to \$136,541.29.**

18 **BE IT FINALLY RESOLVED that the Executive Branch is authorized to expend funds for the**  
19 **program listed herein above in the amount indicated.**

24 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
