

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving and authorizing the use of a portion of the remaining funds from Resolution**  
**No. 03-218 to amend the Hia-Ced O'odham Planning and Development Budget)**

**RESOLUTION NO. 04-160**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the purchase of the 635 acre**  
2 **property known as the Roberts Property for the Hia-Ced O'odham and appropriated**  
3 **1.8 million dollars for land acquisition costs and set aside any remainder for**  
4 **unforeseen expenses related to the Roberts Property; and**

5 **WHEREAS, after the purchase of the land a fund of \$288,855.54 remained; and**

6 **WHEREAS, in Resolution No. 04-021 the Tohono O'odham Legislative Council did support and**  
7 **approve the Hia-Ced O'odham Planning and Development Budget request in the**  
8 **amount of \$73,203.48, to be taken out of the \$288,855.54 remainder, to be**  
9 **administered by the Hia-Ced O'odham Program in collaboration with the Hia-Ced**  
10 **O'odham Advisory Committee for the planning and development of the newly**  
11 **acquired land base; and**

12 **WHEREAS, the Hia-Ced O'odham Advisory Committee is requesting to amend the budget to**  
13 **utilize an additional \$86,619.00 of the remaining funds (\$215,652.06) from Resolution**  
14 **No. 03-218 to address additional needs identified for the community development**  
15 **and planning process for the Hia-Ced O'odham.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **support and approve to amend the Hia-Ced O'odham Planning and Development**  
18 **Budget request in the amount of \$86,619.00 to be expended by the Hia-Ced O'odham**  
19 **Program in collaboration with the Hia-Ced O'odham Advisory Committee for the**  
20 **planning and development of the newly acquired land base.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>, Day**  
22 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 1,258.7 FOR; 622.3**  
23 **AGAINST; 748.7 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
24 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
27 **18, 1934 (48 Stat. 984).**


