**RESOLUTION NO. 04-162**

1 **WHEREAS, the Tohono O'odham Nation approved FY 2004 BIA 638 Social Services Budget on**  
2 **September 30, 2003, Resolution No. 03-436 in the amount of \$2,683,090.20; and**

3 **WHEREAS, the Tohono O'odham Department of Human Services is presently operating the**  
4 **Divisions of Family Assistance, Child Welfare and Senior Services through an**  
5 **approved FY2004 BIA 638 budget; and**

6 **WHEREAS, budget amendment number one has been submitted using savings of an additional**  
7 **\$32,489.56 allocation for administrative program operations, adding a new line item**  
8 **– Non-Major Capital Equipment for purchase of non-capital equipment, and an**  
9 **additional \$359,803.39 allocation of welfare assistance funds to provide for an**  
10 **increase in the foster care rates for Child Welfare; and**

11 **WHEREAS, any amendments affecting the funding or funding levels of the contract shall be**  
12 **submitted for review and approval by the Tohono O'odham Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 14 **1. It hereby approves and authorizes FY2004 BIA 638 budget amendment number**  
15 **one for the Department of Human Services, Divisions of Family Assistance, Child**  
16 **Welfare and Senior Services in the total amount of \$3,075,273.97.**
- 17 **2. Approves and authorizes expenditures in accordance with the attached budget**  
18 **amendment.**
- 19 **3. The Tohono O'odham Nation's Official to wit: The Chairwoman is hereby**  
20 **authorized to negotiate and execute the contract.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
22 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,164.1 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and 465.6 [06] ABSENT, pursuant to the powers vested in the Council by Section**  
24 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
27 **Stat. 984).**
