16 **line Items are to be reviewed and approved by the Baboquivari District Council and**
17 **the Tohono O'odham Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
19 **Artesia-Little Tucson amendment and budget modification number two.**

20 **BE IT FINALLY RESOLVED, that the budget modification in the amount of One Thousand Dollars**
21 **and No Cents (\$1,000.00) be distributed to the above aforementioned new line item**
22 **emergency assistance.**

24 **of APRIL, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**

26 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
27 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
28 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
