

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Monetary Contribution of \$1,137.04 for the Graduation Exercises for the
Baboquivari High School and 8th Grade Class)**

LEGISLATIVE ORDER NO. 04-183

1 **WHEREAS, Baboquivari High School Senior Class and 8th Grade Class is requesting for monetary**
2 **support for their graduation exercises to be held at Desert Diamond Casino on**
3 **Nogales Highway from this Council; and**

4 **WHEREAS, a proposal was submitted to the Legislative Branch for an amount of \$1,137.04 which**
5 **exceeds the Legislative Branch Budget Contributions Line item which is capped at**
6 **\$500.00; and**

7 **WHEREAS, the Chairwoman of the Tohono O'odham Nation does support a cost share with this**
8 **council; and**

9 **WHEREAS, the Legislative Council does support the request for monetary donation.**

10 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council does authorize**
11 **the donation or \$1,137.04 to support the Graduation Exercises for the Baboquivari**
12 **High School and the 8th Grade Class.**

13 **BE IT FURTHER ORDERED that the \$500.00 cap under the Contribution Line Item of the Legislative**
14 **Branch Budget be waived for this request.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 5TH Day of MAY,**
16 **2004 at a meeting at which a quorum was present with a vote of 1,289.0 FOR; 1,164.6 AGAINST; 176.1**
17 **NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) of**
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
