

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 04 Schuk Toak District Budget Amendment #1)**

**RESOLUTION NO. 04-186**

1 **WHEREAS, the Schuk Toak District Administration presented to the Tohono O'odham Legislative**  
2 **Council the District FY 04 budget amendment #1 adding additional funds to cover**  
3 **expenditures to the end of the fiscal year; and**

4 **WHEREAS, the Tohono O'odham Legislative Council did on October 09, 2003 previously approved**  
5 **the Schuk Toak District Six (6) Month Budget for Fiscal Year 2004 in the amount of**  
6 **\$154,846.87; and**

7 **WHEREAS, the Schuk Toak District Council at its special meeting held on April 27, 2004 did**  
8 **review and approve the District Administration budget amendment adding**  
9 **additional monies in the amount of \$194,713.24 and the youth budget in the amount**  
10 **of \$31,911.20 utilizing Schuk Toak District FY 04 budget reserves per the attached**  
11 **resolution; and**

12 **WHEREAS, there are sufficient funds in the Schuk Toak District accounts held by Wachovia**  
13 **Securities to cover the approved budget amendment.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
15 **the Schuk Toak District FY 04 Budget Amendment #1 in the amount of \$194,713.24 for**  
16 **Administration and \$31,911.20 for the Youth to be expended in accordance with the**  
17 **attached budget.**

18 **BE IT FINALLY RESOLVED that the Schuk Toak District FY 04 budget is hereby modified from**  
19 **\$154,846.87 to the approved level of \$349,560.11.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
21 **of MAY, 2004 at a meeting at which a quorum was present with a vote of 2,209.8 FOR; -0- AGAINST;**  
22 **419.9 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**  
23 **(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
