

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Request Approval to Expend Additional Appropriation of \$2,400,000, Provided by
Resolution No. 03-548 for Dialysis Facility Construction: Amending Current Dialysis
Facility Budget to Include the Additional Appropriation to \$4,002,754.92)**

RESOLUTION NO. 04-205

- 1 **WHEREAS, out of all the causes of death, Diabetes Mellitus is 68.1 per 100,000 for O'odham**
2 **compared to only 10.1 per 100,000 for the United States and 29.1 per 100,000 for all**
3 **I.H.S. areas, thus making incidence of Diabetes Mellitus for the Tohono O'odham**
4 **680% higher than the overall averages for the United States; and**
- 5 **WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 99-443, appropriate**
6 **funds for the initial design and construction (including project administration) of a**
7 **23-chair Dialysis Facility in the amount of \$2,532,002; and**
- 8 **WHEREAS, through the contracted design and development stage the need for a proposed 44-**
9 **chair facility was identified and designed, but the initial appropriation of \$2,532,002**
10 **was insufficient, requiring additional appropriations; and**
- 11 **WHEREAS, the administration of the project and initial design services expenditures, provided**
12 **project carry forward is \$1,622,754.92, not including interest on the principal; and**
- 13 **WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 03-548 approve and**
14 **appropriate an additional \$2,400,000.00 required for design and construction of an**
15 **expanded facility; and**
- 16 **WHEREAS, by Resolution No. 03-548, the \$2,400,00.00 including the existing budget carry forward**
17 **of \$1,622,754.92 added to total \$4,022,754.92 for FY 2004.**
- 18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
19 **approve and authorize the expenditure of the additional authorization of**
20 **\$2,400,000.00, and budget carry forward in the amount of \$1,622,754.92 in accordance**
21 **with the attached budget for fiscal year 2004.**
- 22 **BE IT FURTHER RESOLVED, that the Tohono O'odham Legislative Council does hereby approve and**
23 **authorize for expenditure, \$4,022,754.92 for fiscal year 2004.**
- 24 **BE IT FINALLY RESOLVED that the Legislative Council hereby approves the use of the funds**
25 **specified from the following reserve accounts to administer and construct the**
26 **proposed Dialysis Facility for the Tohono O'odham Nation.**

7 Stat. 984).


