

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2004 Woman, Infants, & Children (WIC) Program Tribal Base Budget**  
**@ \$103,050.30 Modification #1)**

RESOLUTION NO. 04-220

1 WHEREAS, the Tohono O'odham Nation is presently providing health care for women, infants  
2 and children; and

3 WHEREAS, funding for the operation of the Women, Infants & Children (WIC) Program has been  
4 provided in part through supplemental funding sources; and

5 WHEREAS, the WIC Program has obtained a modular building, the Women, Infants and Children  
6 Program has modified FY 2004 Tribal Base Budget to add in Professional Services line  
7 item in the amount of \$11,230.44 for the payment of cost and expenses related to the  
8 installation of utility hook-ups; and

9 WHEREAS, a budget modification is submitted for review and approval by the Department of  
10 Human Services, Division of Community Health Services.

11 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:

- 12 1. It hereby approves and authorizes expenditures in accordance with the attached  
13 budget modification #1 submitted by the Division of Community Health.
- 14 2. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice  
15 Chairman and any designated Official are hereby authorized to negotiate and  
16 execute this contract.

17 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day  
18 of JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,017.2 FOR; 262.6  
19 AGAINST; 349.9 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
20 Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
21 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
22 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
23 Stat. 984).


