(Setting Special Session dates of July 8 & 9, 2004 for Mandatory Workshop on Enrollment Ordinance)**

**LEGISLATIVE ORDER NO. 04-222**

1 **WHEREAS, during the June 2004 General Session the Rules Committee did request that the**  
2 **Legislative Council establish special session dates as follows: July 8 & 9, 2004 -**  
3 **Enrollment Ordinance Workshop; and**


4 **WHEREAS, the Rules Committee has recommended mandatory attendance of Councilmembers**

6 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
7 **establishes special session dates of July 8 & 9, 2004 to hold a workshop on the**  
8 **Enrollment Ordinance.**


9 **BE IT FURTHER ORDERED that Councilmembers are hereby mandated to attend the Enrollment**  
10 **Ordinance Workshop.**

11 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>, Day of**  
12 **JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
13 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
14 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
