

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting August 23 & 24, 2004 Special Session for Rejection Hearings Pursuant to**  
**Article VIII, 1(B) of the Enrollment Ordinance)**

**LEGISLATIVE ORDER NO. 04-224**

1 **WHEREAS, according to the Legislative Rules, Article I, Section 1.D.1., "The Legislative Council**  
2 **may, by majority vote, call for a Special Session to be held for the purpose of**  
3 **completing unfinished agenda, addressing issues requiring Executive Session, and/or**  
4 **reviewing special reports from Committees, Programs, or other sources.";** and

5 **WHEREAS, the Legislative Council Rules Committee has requested that a Special Session be set**  
6 **for August 23 & 24, 2004 to address Rejection Hearings pursuant to Article VIII, 1(B)**  
7 **of the Enrollment Ordinance.**

8 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby sets a**  
9 **Special Session for August 23 & 24, 2004 to address Rejection Hearings pursuant to**  
10 **Article VIII, 1(B) of the Enrollment Ordinance.**

11 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>. Day of**  
12 **JUNE, 2004 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
13 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (a) of**  
14 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
15 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
16 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
